

2010 PORA POOL RULES

1. All PORA facilities are for members and their guest only! You are required to bring your card key every time you visit the pool or tennis courts. Card keys will be checked and you will be asked to leave if you cannot produce your membership card key.
2. No smoking in the pool area.
3. Children who are not potty trained must wear a swim diaper.
4. Conduct in any area of the pool facility by members or guests must not jeopardize the safety of any individual, including themselves. No running or diving in restricted areas.
5. Only one person on the diving board at a time.
6. The lifeguard may close the diving board for pool games for only a period of 20 minutes. The diving board can not be closed immediately after adult swim.
7. In the event of thunder or lighting, the pool must be cleared of all swimmers for a minimum of 20 minutes.
8. Absolutely no glass is allowed in the pool area.
9. When leaving, members and their guest must clean up their area and have all trash thrown away.
10. Lap swimmers have priority in the swim lane at all times, no exceptions. Please keep children out of the swim lane if it is in use. Lap swimmers would have a very difficult time anticipating a child in their path and it would be very dangerous to the child and the swimmer.
11. You can not take a Post Oak resident to the pool as your guest, they must be members.
12. No pets allowed in the pool area.
13. Children less than 11 years old may only use the pool with a parent, guardian or babysitter present. Babysitters must have prior approval by Chris Disser or Lynn Andruszko. A babysitter is defined as an individual at least 13 years old, who is hired by a PORA member. The babysitter must be attentive to the child's whereabouts and be capable of providing emergency care if needed. Children less than 11 cannot use the pool while a parent is playing tennis; the parent must be inside the pool area at all times.
14. Violation of any of these rules will result in expulsion from the pool.

LIFEGUARD DUTIES AND AUTHORITY

1. The lifeguard is in charge of the pool at all times.
2. The lifeguard does not supervise the wading (baby) pool. A parent must accompany their child in the wading pool.
3. Once an hour, the lifeguard is entitled to a 10 minute break. During these ten minutes it is considered adult swim, no children are allowed in the pool. Our insurance and our contract with Swim Atlanta specify that no one under 18 years of age is to be in the pool at this time, excluding infants held in their parent's arms.
4. Only lifeguards, supervisors or board members may enter the pump room or guardroom.

SWIM AT YOUR OWN RISK (SAYOR) RULES:

NO LIFEGUARD ON DUTY

1. SAYOR Hours refers to the time the pool is open but no lifeguard is on duty.
2. PORA members, by paying dues, have consented to all the terms of SAYOR and the liability release outlined in the Extended Hours Liability Release form received with membership invoice.
3. The diving board will be closed and cannot be used.
4. No alcohol.
5. Members must be at least 18 years old or accompanied by a parent. No babysitters. There are **NO** exceptions to this rule.
6. Please clean up after yourselves.

2010 PORA POOL GUEST POLICY

1. Guests cannot be a resident of Post Oak Square or Post Oak Springs.
2. A member family may bring up to 5 guests at one time. Any more guests will be considered a party and requires the approval of Chris Disser and Lynn Andruszko, Pool Co-Chairs.
3. Individuals may be a guest at the facility no more than three times per year.
4. All guests must be accompanied by a member.
5. No guests allowed at the facility in any business or paid capacity.
6. All guests must sign in.

***** ANY OF THESE RULES MAY BE CHANGED, AMENDED OR MODIFIED BY THE PORA BOARD OR THE LIFEGUARDS AS WARRANTED OR NEEDED. COMMON SENSE WILL APPLY. ANY PORA BOARD MEMBER OR SWIM ATLANTA EMPLOYEE HAS THE AUTHORITY TO EVICT ANYONE THAT VIOLATES PORA POOL RULES.**
